



# Pike County Health Department Food News

---

## *Pike County food service inspections for September 2018*

A perfect score on an inspection is 100%. Points are subtracted if violations are found. 85-100% indicates compliance with health department guidelines. 70-84% indicates the establishment must be re-inspected within thirty (30) days. If the violations have not been corrected the establishment faces possible closure. 60-69% indicates the establishment will have five (5) days to request a hearing to show why it should be permitted to continue operations. 59% or less indicates an automatic immediate closing of the establishment if conditions pose an immediate health risk to the public. Certain conditions and practices are considered potentially serious threats to the public health. These require correction within ten (10) days. An asterisk appearing before the restaurant score denotes such deficiencies. An asterisk appears before the name of an establishment, who has had a follow-up inspection, if violations are not corrected and require another follow-up inspection.
